SUMMARY OF RULES & REGULATIONS

1. Have FUN!
2. Obey the lifeguards.
3. No running or pushing.
4. No chewing gum.
5. No glass containers.
6. No food or drink on the pool deck.
7. Only one person at a time allowed on the diving board.
8. No swearing or offensive language.
9. Children under 8 years of age *will not* be permitted to enter the pool premises unless accompanied by a responsible person 14 years old or older.
10. If something is not to your liking, please talk to the pool manager. It's your pool!

The rules and regulation are set up for the health, welfare and safety of all members. The primary purpose of the pool and these rules and regulations is to provide enjoyable recreation for all members of the association.

The pool management is responsible for the proper enforcement of the rules and regulations listed here.

These rules may be revised or additional rules established as considered necessary by the Board of Directors. Situations which are not covered specifically by any rule or regulation herein will be handled at the discretion of the Manger or Lifeguard in charge and will be reported to the Board of Directors.

Section 1 – Safety

1. All persons are expected to obey the instruction of the lifeguards and/or the manager.
2. No person may use the pool unless it is officially open and the lifeguards are on duty. During the swim team practice, only persons involved with the swim team will be permitted admission to the pool.
3. Running, pushing, wrestling, dangerous horseplay, profanity and other objectionable conduct, which in the opinion of the guards represents a danger for anyone in the pool or any area of the establishment, is prohibited. Fighting is specifically prohibited, and offenders will be immediately expelled from the pool and subject to suspension from pool premises. (Pursuant to the By-Laws, Article 6, Section 6, para E and F.)
4. No life rafts, boats, air mattresses, inner tubes or hard balls (with the exception of the approved pool basketball) are permitted in the main pool except during designated periods (e.g. Float night). The pool board or lifeguard has the right to restrict the use of any raft deemed to present a danger to other swimmers or that restricts the lifeguards' visibility.
5. Small Nerf-type balls, noodles and beach balls are allowed in main pool at the discretion of the lifeguard.
6. Children under 8 years of age will not be permitted to enter the pool premises unless accompanied by a responsible person 14 years or older. In accordance with Child Protective Services, children who are 8 and 9 years old may be left alone for not longer than 1-1/2 hours. Children who are 10 and 11 years of age may be left alone for not longer than 3 hours on an infrequent basis. Any child between the ages of 8-16 who will be left alone must have a signed Safety Conduct Card with emergency information on record in the office.
7. Persons unable to demonstrate their ability to swim to the lifeguards are not permitted in deep water.
8. Non-swimmers must have a responsible swimmer in the pool with them within arms' reach at all times.
9. No persons are allowed to gather around the lifeguard chairs. Talking to lifeguards on duty is permitted only when necessary.
10. Absolutely no glass containers of any kind are permitted on the pool premises. With the exception of service animals, no pets of any kind will be allowed on the pool premises.
11. All injuries occurring on the premises must be reported immediately to the management. Accident report forms are available at the pool.

Section 2 – Health

1. Admission to the pool is refused to all persons having any skin disease, inflamed eyes, colds, nasal or ear discharge, communicable diseases, excessive sunburn, open lesions, or wearing bandages of any kind.
2. Spitting, spouting of water, blowing the nose, etc., is not permitted in the pool or on the deck.
3. Intentional defecation in the main pool or on the deck to the main pool carries an automatic penalty of being refused admission to the main pool for 30 days. (Pursuant to the By-Laws, Article 6, Section 6, para E and F.) Children not fully potty trained must wear tight fitting plastic pants and special swim diapers. Regular disposable diapers are not permitted, as they become a drowning hazard when wet.
4. Lifeguards shall clear the main pool of children younger than 16 years of age once every hour for a 15-minute rest period. An adult may take one child into the pool during the break time; this child must be a non-swimmer and/or 6 years of age or under.
5. Street clothes are not to be worn in the pool; wear appropriate swimming attire only.
6. All trash must be placed in containers provided for such purposes.

Section 3 – General

1. Per Fairfax County regulations, no food or drink other than water is allowed on the pool deck
2. Smoking is permitted only in the designated smoking area. Cigarette butts and ashes must be deposited in designated containers.
3. Chewing gum will not be allowed on the pool premises.
4. Chairs cannot be reserved.
5. The cost of intentional property damage will be charged to the responsible member. (Pursuant to the By-Laws, Article 6, Section 6, para E and F.)
6. There will be no loitering on the pool property, including the parking lot and wooded area.. (Pursuant to the By-Laws, Article 6, Section 6, para E and F.)
7. All bicycles must be parked and locked in the bike rack provided at the entrance to the pool. No bicycles shall be brought within a fenced area of the pool property.
8. No unauthorized (no tags, etc.) motorized vehicles shall be allowed on pool premises (the parking lot and wooded property).

9. Portable music players (i.e. iPods, boom boxes) shall not be played in a manner which interferes with other members or guests.
10. No unauthorized persons are allowed in the guard station at any time

Section 4 - Diving Regulations

1. Only one person on the diving board ladder or diving board at one time.
2. Do not dive until the previous diver has reached the ladder or cleared the diving area.
3. Dive only straight out from the board (Diving or jumping toward the sides of the pool is prohibited). Horse-play or excessive bouncing on the diving boards is prohibited.
4. No general swimming in the diving board area, except when approved by lifeguards.
5. Swimmers unable to pass a swim test consisting of, at a minimum, competently swimming a least one full length of the pool without stopping and treading water continuously for a least one minute, may not use the diving board.
6. No diving with or onto floatation devises

Section 5 - Baby Pool Regulations

1. The pool management does not furnish lifeguard services in the baby pool enclosure. Therefore, parents or person delegated by parent will:
 - a. be in charge of the children they bring into the baby pool area;
 - b. not leave children unattended.
2. Use of the baby pool area shall be limited to children 6 years of age and under. (Older children are to stay out of this area even during rest periods.)
3. Children not fully potty trained must wear tight fitting plastic pants and special swim diaper.

Section 6 - Guest Regulations

1. Guest access is controlled through a guest pass that can be purchased at the front desk. Below is a sample of guest pass.

2. The office guard will be responsible for providing the following information for each guest pass issued:
 - Date
 - Name of Member
 - Number of Visits Allowed on Punch Card
 - Cost
3. Guest passes are kept in the membership book in the guard office.
4. A non-member (i.e. guest) will be allowed access to the pool when accompanied by a member with a valid guest pass. The office guard will punch the guest pass for each guest entering the pool. Guests must be accompanied by the member at all times. Each guest will be allowed access to the pool for the entire day.
5. Awarded guest passes are only valid in the year issued. Refunds will not be provided for guest passes not used or lost.
6. A guest pass is required for all guests over the age of 1 who are staying on the premises. Children under 1 do not require a guest pass as long as they are accompanied by a parent or responsible adult and a pool member.
7. Guest passes cost \$35.00 for five guest passes or \$70.00 for ten guest passes. Single guest passes are not sold

Section 7 - Admission Requirements

1. Entrance to the pool will be controlled by a pool guard.
2. The pool clerk shall provide a membership book which will contain the names of each pool member. Access to the pool is permitted after the pool guard verifies membership from the membership book.
3. If a member name is not in the membership book, the member may be permitted access for one day only with the approval of a pool board member or pool clerk. Further access to the pool is allowed only when the member name is added to the membership book or other proof of membership is provided.
4. Guests must always be accompanied by a member. The pool guard will punch one hole from the guest pass for each guest.

Section 8 - Equipment Checkout

1. Access to equipment will be on a first-come first-served basis.
2. A twenty-five cent security deposit may be charged for equipment. The security deposit will be returned only if the equipment is brought back the same day and by the same person who had checked out the equipment.
3. Security deposit money not returned will be used to purchase additional equipment.
4. Items in the lost and found area are member's personal property and are not free for the taking. However, twice a season unclaimed items may be donated to non-profit organization after a 2-week notice.

Section 9 – Private Parties

1. The pool manager or assistant manager must be notified at least a week in advance of a party request. The member must complete a request form. The deposit is due at time of booking.
2. Parties are to be held during regular pool hours. After hour parties can be arranged, but may require a noise permit and extra costs associated with paying guards overtime.
3. Host must provide a list of attendees to the guards so the guests can be checked in at the front office as they arrive.
4. All party guests who want to swim are subject to swim testing by the guards. Babies must be in swim diapers and rubber diaper covers.
5. Guards may open lower gate only for short periods (5-10 minutes) to facilitate unloading before and loading after the party. The guard must remain and monitor the gate while it is open.

6. ***Any group with more than 10 guests shall be considered a party.*** For safety purposes, all parties must be registered online (preferred), or by calling the party coordinator, with or without rental of the pavilion. This ensures that the guards and board have advanced notice, in case extra guards are needed, and a guest list so that they can approve entry.
7. Depending on the size of the party, and if other parties are scheduled at the same time, the host member may be asked to set up a separate picnic area to be designated by the pool manager, so that Kathy's Korner remains available to members. No more than 3 tables at Kathy's Korner can be used at a time for a single party.
8. If extra guards are required for any individual party (typically 50+), the host will be responsible for the extra fees incurred by the pool.
9. As with all guests, the host must be present while any non-member guests are on the premises.
10. Guest passes must be purchased in advance, and a \$50 deposit will be required, which will be returned after it has been determined that everything has been cleaned per the party cleanup checklist.
